## Annexure - A

### TERMS AND CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract/hiring, shall have all necessary valid MV document such as :- valid Registration Certification, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L of the Driver available all the time.
2. The Department / Office hiring the vehicle shall not be responsible for any damage/loss caused to hire vehicle or loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall not be responsible for all search litigation.
3. The hire charges inclusive all taxes is to be paid for the monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption as per the existing govt norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubrication oil of the engine, gearbox and different coolant, tyres and tubes battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.
5. In case of the breke down for the reasons what ever the replacement of the vehicle of the same or the better models shall be provided by the owner of the vehicle/bidder.
6. In case of the vehicle dontt report regularly, the authority will be at liberty to terminate the agreement without prior notice.
7. The vehicle shall report for duty for minimum of 25 days in month.
8. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment should demanded.
9. Monthly hire charges and the reimbursements towards cost of fuel(as per actual) of the selected bidder will be paid in every succeeding month, as per possible within 15 days of the submission of the bill by the service provider and no advance payment will be made.
10. The vehicle shall not be more than 5 years old from the initial registration and also in good running condition during the period of contract.
11. If the services are found to be unsatisfactory, the client shall give 7 days notice and terminate the agreements.
12. In case the service provider intends to withdraw the service of the vehicle and terminate the agreement, it shall be mandatory upon him to give 30 days notice before such withdrawal. Such service cannot be terminated of agreement.
13. If the bidder violates any of the terms of the contract, the government shall forfeit the entire amount of security deposit.
