



If the office happens to be closed on the date of opening of bids as specified, the bids will be opened on the next working day at the same time and venue.
- As per the Works Department Letter No 5310/Dtd. 02.05.2009 and Letter No 5140/ Dtd 28.04.2009, **Labour cess @ 1% (one percentage)** of the total cost of construction will be deducted from the bill of the contract.




