In exercising powers conferred upon me under Section- 115 of Motor vehicle Act, 1988, I, Somesh Kumar Upadhyay, IAS, District Magistrate, Dhenkanal having been authorized under sub-rule (1) of Rule 173 of Orissa Motor vehicle Rules, 1993 do hereby restrict plying of Heavy Goods Vehicles (Truck /Tipper/ Trailer etc) in Kapilash-Tangi PWD Road in Gondia Block from Deogan to Chhatighara and vice versa (under jurisdiction of Gondia area) in Dhenkanal District to minimise the life threaten of wild life animal of Kapilash Wildlife Sanctuary.

This restriction / prohibition shall remain in force for a period from dt. 01.01.2025 to 31.01.2025 from 6.00 PM to 6.00 AM.
