



Expression of interest for selection of Cluster Level Self Help Group for Establishment of Bio-input Production unit under the programme “Promotion of indigenous aromatic and non-aromatic paddy with export potential/local market” in the State of Odisha under the scheme “Crop Diversification Programme”.

The Chief District Agriculture Officer, Dhenkanal invites Expression of Interest (EOI) from Interested Self Help Groups (SHGs) for establishment of Bio-input production units. It is planned to select 6 Self Help Groups (Normal-3, SCP-1, TASP-2), who in-turn will establish 6 Bio-input production units @1 each in 6 Cluster under the scheme “**Promotion of indigenous aromatic and non-aromatic paddy with export potential/local market**” in Hindol block, Eligible Self help Groups (SHGs) are required to submit the proposals in sealed envelope super-scribed as “**Application/proposals for selection of Cluster Level Self Help Group for Promotion of indigenous aromatic and non-aromatic paddy with export potential/local market in the State of Odisha**” as per the enclosed application format by registered/speed post by 17.04.2025 up to 1PM. Application /proposals in e-mail or in other forms will not be entertained. The duly filled EOI should be addressed to the Block Agriculture Officer of Hindol block, Dhenkanal. The proposals shall be opened on 17.04.2025 at 3.00 PM in office of Block Agriculture Officer, Hindol in the presence of authorized signatories or representative of the participating organization /agencies. The application form and the term & conditions are available at the website of www.dhenkanal.nic.in. The common minimum criteria for the selection of the SHGs and the details are appended at annexure E for ready reference of the interested SHGs.

The authority shall not be responsible for any sort postal delay and application/proposals received beyond scheduled date and time shall not be entertained & outright to be rejected. The authority reserves the right to cancel/reject any or all the EOI without assigning any reason thereof.

9.2. Process of selection of SHG at Cluster level

9.2.1. Selection Procedure of SHG:

For 100Ha. cluster, 1 no of SHG will be selected for establishment of Bio-input production unit under the programme "Promotion of Indigenous aromatic and non-aromatic paddy with export potential/ local market". Advertisement of Expression of Interest is to be published/notified by the CDAO of the district concerned for a period of at least 15 days. Once applications are received at the block level, scrutiny of documents, field verification and shortlisting of SHG will be done by Block Level Committee:

9.2.1.1. Block Level Committee

The Block Level Committee is formed of the following members.

- Block Development Officer-Chairman
- Block Agriculture Officer/Assistant Agriculture Officer-Convener
- Assistant Agriculture Engineer-Member
- CDPO- Member
- BPM, OLM - Member

- a. The Block Level Committee shall be convened within 5 days of receipt of the proposal from the SHGs.
- b. BAO/AAO shall prepare a list based on the received Expression of Interest and place it before the Block Level Committee.
- c. The Block Level Committee shall examine the proposal of SHGs considering the feasibility of the proposed agri-ventures with respect to adequate availability of raw materials, financial viability and marketing.
- d. The Block Level Committee will examine the list on a case-to-case basis and suitable SHGs will be recommended to the District Level Committee.
- e. Preference should be given to the SHGs those are working inside clusters of the Block.
- f. The District Level Expert Committee shall be convened within 10 days of receipt of the proposal from the Block Level Committee.
- g. The District Level Expert Committee will examine the recommendations of the Block Level Committee and approve suitable SHGs as per the requirements of different clusters.
- h. The CDAO shall furnish the approved list of SHGs along with the respective agri-venture unit to the Director of Agriculture and Food Production.

9.2.1.2. Common minimum criteria for selection of SHG:

- a. SHGs must be registered under any appropriate authority (SHG/WSHG/LG etc).
- b. SHGs should be interested to be involved with the project activities and should submit a letter of intent along with a resolution to CDAO.
- c. The SHGs will arrange minimum land required for establishment of Bio-input Production Unit before the signing of tripartite MoU with CDAO and CBO.
- d. If the required land does not stand recorded in the name of the SHG, the land recorded in the name of any member of the SHG to be considered. In such a case,

there will be an unregistered agreement for a period of 5 years on non-judicial stamp paper between the land owing member and the concerned SHG. This will be passed through or recorded a general meeting resolution of the SHGs.

- e. Must have completed at least 1 year of existence.
- f. The SHG must not defunct or defaulter from the Bank loan.
- g. SHGs must have an active bank account in the name of group.
- h. SHGs must be regular in systematic book-keeping such as Meeting Register, Cash-book and other mandatory documents.
- a. Preference should be given to the SHGs having prior experience in the production & marketing of bio-inputs.

9.2.1.3. Specific criteria for establishing Bio-Input units

- a. The Bio-Input unit shall be run and managed by SHG.
- b. The unit should be established based on easy access to biomass, required raw materials like cow dung, cow urine, agriculture waste etc.
- c. They should engage in creating diversity also with planting activities of required plants commonly used for bio-manure and bio-pesticide preparations.
- d. The SHG shall be responsible for the complete mobilizing community and delivery services for Bio-inputs suggested in the programme.

N. B.: The criteria mentioned for the selection of CBOs/SHGs may be modified as per the local situation for smooth selection of the CBOs/SHGs with approval in the District Level Monitoring Committee Chaired by Collector & District Magistrate.
