4. The receipt of the bid documents will start from Dt. 19-04-2025 07.00 AM to 28-04-2025 till 1.00 p. m only through Registered Post/ Speed Post addressed to The Block Development Officer Bhuban, Dist. - Dhenkanal, Odisha, PIN – 759017. Delay due to postal will not be considered at any cost.
5. The bids will be opened on Dt-30-04-2025 at 10.00 AM in the office of the under signed in the presence of the bidders or their authorized persons who wish to attend. If the office happens to be closed on the opening day, the bids will be opened on the next working day at the same time and venue accordingly.
6. Bidding documents will be available in the District website i.e. Dhenkanal.nic.in and the same can be downloaded and submitted along with the relevant documents duly filled up and the same can be submitted to The Block Development Officer Bhuban by Registered Post/ Speed post within the stipulated time mentioned above and the Authority will not be held responsible for any kind of postal delay (dispatching Bid documents/receiving sealed Bids), if any.
