6. The bids will be opened on **Dt-18.06.2025 at 11.00 AM** in the office of the under signed in the presence of the bidders or their authorized persons (the authorization letter by the Tenderer should be

- produced) who wish to attend. If the office happens to be closed on the opening day, the bids will be opened on the next working day at the same time and venue accordingly.

Otherwise, his / her bids shall be declared as non-responsive and thus liable for rejection and the bidder will be declared as Black Listed for 2 years by the Department and the EMD amount will be forfeited. The same tender will be rendered further.


