5. The bids will be opened on Dt-02-07-2025 at 11.00 AM in the office of the under signed in the presence of the bidders or their authorized persons who wish to attend. If the office happens to be closed on the opening day, the bids will be opened on the next working day at the same time and venue accordingly.


