The receipt of the bid documents will start from **Dt.10-06-2025 at 07.00 a.m. to Dt-18-06-2025 till 5.30 p.m. Only through Registered Post/ Speed Post addressed to The Block Development Officer Kankadahad, Dist. - Dhenkanal, Odisha, PIN – 759028. Delay due to postal will not be considered at any cost.**
6. The bids will be opened on **Dt-19-06-2025 at 11.00 AM** in the office of the under signed in the presence of the bidders or their authorized persons who wish to attend. If the office happens to be closed on the opening day, the bids will be opened on the next working day at the same time and venue accordingly.
