

Block Development Officer, Kamakhyanagar on behalf of Governor of Odisha, invites percentage rate bids for the works detailed in the following table from class of contractors mentioned in Col-4 below registered with the State Government and contractors of equivalent grade/ class, registered with Central Government/ MES/ Railways to be eventually drawn up in PWD F-2 (Now P-1) form for execution of civil works, on production of definite proof from the appropriate authority. But successful bidder of other State/ MES/ Railway/ CPWD in equivalent rank has to register under the State PWD before signing the agreement. The bidders may submit bid for the following works.

2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and condition of contract and other necessary documents can be seen in the office issuing the documents as specified in the table at Col.- 6 above during office hours every day except on Sunday and Public holidays till last date of sale and receipt of the tender papers. Interested bidders may obtain further information at the same address.
3. Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table at Col.- 5 above, in shape of N.S.C./ K.V.P./ P.O.T.D./ Post Office Savings Pass Book/ Deposit receipt of any scheduled Bank (valid for minimum one year from the date of receipt) duly pledged in favour of **"Block Development Officer, Kamakhyanagar"**. Bids without E.M.D. or in other shape will not be considered and liable for rejection.
N.B. :- E.M.D. in shape of cash/ Pay Orders or Bankers Cheques/ Bank Draft is not acceptable.
4. The sale and receipt of the bid documents shall start from dt. **01.08.2025 to dt. 15.08.2025** during the office hours i.e. **from 10.00 AM to 5.30 PM except on Sundays and Public Holidays**. Bids shall be sold and received in the office as stated in the table at Col.- 6 above as well as in the District web portal (<https://dhenkanal.odisha.gov.in>). The bidders may download the DTCN from the district web portal only during the aforesaid period. The cost of the bid document as mentioned in the table above at Col No. – 7 above, has to be paid by each bidder in shape of demand draft drawn in favour of **Block Development Officer, Kamakhyanagar and payable at Kamakhyanagar** from any scheduled

- Commercial Bank. Bid document will be received during the period **from dt. 01.08.2025 to dt. 15.08.2025** during the Office Hours in the Office of the Block Development Officer, Kamakhyanagar through **Registered Post/ Speed Post** only. No other mode of submission is acceptable.
5. Bids must be delivered through **Registered Post/ Speed Post** having **Identification No. Panchayat Samiti, Kamakhyanagar – 02/2025-26** and identified with the name of particular work put to Tender. The undersigned is not responsible for postal delay if any, in the delivery of the documents for non-receipt of the same.
 6. Bidders shall submit original affidavit regarding authenticity of their documents and 1% (One Percent) E.M.D. along with their bids. Bids shall be accompanied with the attested true copies of the valid registration certificate, GSTIN and PAN card which are mandatory. The original certificates of the lowest bidder are to be produced within three working days of opening of the tender before Block Development Officer, Kamakhyanagar for verification; otherwise his / her bids shall be declared as non-responsive and thus liable for rejection. Also, the bidder should satisfy the eligibility criteria, provided in the relevant clauses of the bid documents (DTCN).
 7. Bidders can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection.
 8. Engineering Contractor desirous to avail the facility of exemption of E.M.D. is required to submit affidavit to the effect that he/ she has not yet availed the facility for more than two works during the current financial year failing which his/ her tender will be rejected.
 9. The bidder is required to submit "**Bid Security Declaration**" in shape of an affidavit to the effect that, if they withdraw or modify their bids during the period of validity etc., they will be suspended for the time specified in the tender documents. The name of the work and the authority to which the tender has been submitted must be mentioned in the affidavit.
 10. The bid will be opened on **dt. 18.08.2025 at 10.00 AM** in the office of the undersigned in presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
 11. If the rate quoted by the bidder is less than 15 % of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99 % (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system **on the same day i.e. on the date of opening of the Tender**, where all bidders / their authorized representatives, the concerned Executive Engineer and DAO will remain present.
 12. Additional Performance Security shall be obtained from the bidder when the bid amount is 5% and above and below 10% less than the estimated cost put to tender at the rate of 50% of the difference between Estimated Cost put to tender and bid amount. In case the bid amount is 10% and above less than the Estimated Cost put to tender Additional Performance Security at the rate of 150% of the difference between Estimated Cost put to tender and bid amount shall be deposited. Additional Performance Security must be deposited in shape of Demand Draft/ Term Deposit Receipt pledged in favour of Block Development Officer, Kamakhyanagar **within 07 (seven) days**, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
 13. For building and other construction workers, Welfare Cess @ 1% (One Percent) of the cost of the construction shall be deducted from the bills.
 14. Other details can be seen in the bidding documents.
 15. The enclosures other than the D.T.C.N. should be page numbered and signed by the contractor.
 16. Total No. of enclosures submitted by him / her in Numbers and words as per relevant clause of DTCN.
 17. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
