The Earnest Money Deposit (EMD) will be 1 % of the Tender value and should be deposited in shape TDR, FDR, NSC, KVP or small saving deposit from any Nationalized Bank duly pledged in favour of "Block Development Officer", Kankadahad payable at Kankadahad at the time of Bidding and the Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year, failing which his/her tender will be liable for rejection.

If the office happens to be closed on the opening day, the bids will be opened on the next working day at the same time and venue accordingly.
