EXPRESSION OF INTREST (EOI)

Expression of Interest (EOI) is invited from the interested bidders / agencies / reputed firms by the Chief District Agriculture Officer, Dhenkanal for movement of Krushi Rath at different block level for disseminating agriculture messages to the farming community. The Krushi Rath will be decorated in a vehicle with proper sound system to move in all the GPs / important places for 5 (five) days per block. It will be accompanied by a group of Folk Dancers / Drama artists to spread the message at various places by way of Drama / Dance / Pala under the scheme IEC 2025-26. The maximum rate of the total cost of preparation of Krushi Rath should not exceed to Rs. 50,000 /-(including all taxes). The intending bidders / agencies / reputed firms will submit the EOI documents along with proper indexing in a sealed cover to the Chief District Agriculture Officer, Dhenkanal on or before 15.12.2025 through Speed post / Registered post / Courier during the office working hours. The sealed EOI shall be opened on 16.12.2025 at 3.30 PM in presence of the applicants or their authorised representatives. The authority reserve the right to reject any or all quotations without assigning any reason thereof. The EOI received incomplete or after the scheduled date and time shall be summarily rejected. The sealed envelope containing the application should be superscribed with "EOI for Organising Krushi Ratha Programme under the scheme IEC-2025-26".

List of documents to be submitted:-

- The agency must have valid PAN number and GSTIN with up to date income tax and GST clearance certificate.
- The agency should not have been black listed.
- Preference would be given to the agency who have past experience for similar assignments in Agriculture & Farmers' Empowerment Department.
- The vehicle must be in a road worthy condition and shall not be more than 3 years old from the date of initial registration with valid RC, Insurance certificate, Fitness certificate etc and other valid documents which are mandatory for plying of vehicle.
- Driver of vehicle must have valid driving licence for driving.
- The vehicle should cover all blocks including each and every GP of the District mandatorily.
- The distance covered by the Krushi Rath will be certified by the Concerned BAO.
- The artist for the folk dance / drama / Pala will be selected from the list available with the District Culture Officer of the concerned district.
