INVITATION FOR BIDS (IFB)

'E' PROCUREMENT NOTICE NO.- 5695 Dated. 05.12.2025

The Block Development Officer, Sadar, Dhenkanal on behalf of Hon'ble Governor of Odisha invites online percentage rate basis tender for the work in D.T.C.N through e-procurement for execution of the works mentioned below. The bid should be submitted on-line in the Government website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by eligible class of contractors as mentioned below registered with State Government & contractors of equivalent grade/ class registered with Central Government/ MES/ Railway to be eventually drawn in P-1 form. The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month of acceptance of bid. The bidders registered outside the State are required to submit an under taking in the form of an affidavit, that they are not registered under the GST act in the State of Odisha as they have not started any business in the State and they have no liabilities under the Act. But bidder has to produce copy of GSTIN certificate before signing of agreement. For bidders registered within the State, no tender would be considered without a valid GSTIN certificate.


1. Mode of Submission of EMD/Bid Cost : The bidder shall transfer the required amount of EMD/Bid Cost On-line as mentioned for the specified work in Column 4 & 5 respectively in the above table through a process as mentioned in DTCN
2. Mode of submission of Tender : Tender should be submitted on-line in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) each set of bid document and Bill of Quantity in MS Excel format.
3. Period of availability of tenders on-line / date of time of bidding on-line / last date of seeking clarification / date of opening of tender papers. : Details as follows

4. Any addendum / corrigendum / cancellation of above tender will be published in the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in), and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
5. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the works are available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of availability. Interested tenderers may obtain further information at the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
6. The bid for the work shall remain open for acceptance for a period of 90 days from the last date of receipt of bids. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
7. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission.

8. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the Tender documents including Registration Certificate, PAN Card, GST, receipt of bid cost & bid securities. Failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all. Labour license(if any) is to be produced by the successful bidder at the time of agreement.
9. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tender papers of the concerned bidder.
10. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of rest of bids. But if more than one bid is quoted (decimals up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system which will be held on PANCHAYAT SAMITI OFFICE, SADAR ON 29.12.2025 at 03:30. PM in presence of all bidders/their authorized representatives (if they wish so), the Block level tender committee headed by BDO, SADAR. Hence all the bidders can enquire in the office of the undersigned regarding lottery before the scheduled date as no further correspondence to the bidders in this regard will be made. If for any administrative inconvenience, the lottery can't be held on the schedule date, the the lottery will be Conducted on the next working date.
11. If L1 bidder does not turn up for agreement after finalization of the tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor. In that case, the L2 bidder, if fulfils other required criteria will be called for drawing agreement for execution of the work subject to the condition that the L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise the tender will be cancelled.
12. Block Development Officer, SADAR, shall not be responsible for any postal delay and / or non-receipt of the original copy of bid security and bid cost on or before specified date and time. Non submission of cost of Bid and Bid security within the designated period shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked.
13. The Original documents along with a set of its photo copies against the scanned copy of R.C. (Registration certificate), GSTIN, PAN, Affidavit and other requisite documents submitted through web-site should be produced in the O/o the Panchayat Samiti, SADAR, Dhenkanal for verification on demand after opening of the Bid.
14. The Schedule Caste/ Schedule Tribe/ Physically handicapped Contractors desirous to avail the facility of preference or EMD/ISD exemption as per Works Department should produce their original registration certificate stating the fact of Caste/ Physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.
15. Engineering contractor desirous to avail the exemption of EMD is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to whom the tenders have been submitted, must be mentioned in the affidavit & he should produce his original registration certificate at the time of opening of tender failing which the tender will be rejected.
16. The Additional Performance Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional performance security (APS) in shape of Term Deposit Receipt pledged in favour of the Block Development Officer, Sadar, Dhenkanal / Bank Guarantee in favour Block Development Officer, Sadar, Dhenkanal from any Nationalized/Scheduled Bank in India counter guaranteed by it local branch at Cuttack within seven days of issue of Letter of Acceptance (LoA) by the Block Development Officer, Sadar, Dhenkanal (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. (As per Works Department Office Memorandum No.14459/W, Dated 20.09.2018). The details of APS calculation as per



letter No 4559/W, Dated 05.04.2021 of Works Department, Odisha has been mentioned in the DTCN.

17. Other details including details of Portal Registration, Submission of bid, Resubmission and withdrawal of bid can be seen in the bidding document which is available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
18. Any addendum/corrigendum/cancellation of the above tender will be published in the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish can modify their tenders.
19. The authority will not be responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
20. The On-line bidder shall digitally sign on all statements, documents, certificates uploaded by him owning responsibility for their correctness/authenticity as per IT ACT 2000. If any of the information is found to be false/fabricated/bogus, his/her EMD/Bid Cost shall stand forfeited and his/her registration in the portal shall be blocked and bidder is liable to be blacklisted. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof. No tenderer can demand the cause of rejection of his offer.
21. The percentage quoted in the tender without mentioning excess or less shall be treated as excess.
22. The authority reserves the right to cancel any or all bids without assigning any reasons.
23. All other Terms & Conditions shall be governed according to OPWD Code & Other Circulars & Office Memorandum of Works Deptt. Odisha.
