ORDER

In compliance to Order No.1 dated 17.12.2025 of Hon'ble High Court of Orissa, passed in W.P. (C) No. 35907 of 2025, and in accordance with Notice No. IIE-8/2024/167(C) /OSSSC. Dt. 16.02.2024, Letter No. IIE-10/2024/266 (C) /OSSSC. Dt. 27.02.2024 read with the instructions of Odisha Sub-ordinate Staff Selection Commission, Bhubaneswar, vide Letter No. IIE-03/2026/119/OSSSC Dated.15.01.2026, Sri Surya Kiran Nath S/o-Sri Hemant Kumar Nath, At/Po--Hatura, Hindol, Dist-Dhenkanal, is hereby appointed as Junior Revenue Assistant under Odisha Ministerial Services (Method of Recruitment and Conditions of Service of Junior Assistants, senior Assistants and Section Officers in the District Offices and Offices Sub-ordinate thereto) Rules, 2019 for the year 2023, in Cell-1, Level-4 of Odisha Revised Scale of Pay Rules, 2017 with DA & other allowances admissible under rules sanctioned by the Government from time to time.

On appointment he is posted to Tahasil Office, Hindol against the vacant post.

He will be on probation for a period of two years from the date of his joining into the service and the service is subject to the following terms and conditions.

1. The appointment of the probationer may for good and sufficient reasons to be recorded in writing, be terminated by Government at any time without previous notice during the period of probation including extension of such period, if any.
2. He shall abide by the Odisha Civil Services Conduct Rules, 1959 and O.C.S. (C.C. &A) Rules, 1962.
3. He should join on duty at the assigned Office within 30 days from the date of issue of the order, failing which the appointment order shall be automatically cancelled.
4. He has to submit an undertaking to the effect that, he is not continuing in service in any other Department/ Organization etc. at the time of his joining.
5. He should submit the following documents to the authority concerned at the time of his joining in the post.
 - a) Medical fitness certificate signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
 - b) Two character certificates from two Gazetted Officers
 - c) Two pass post size photographs (self attested).
 - d) Copies of Certificates in support of his qualification and date of birth/ resident/caste (self attested).
 - e) Marital declaration, if married, having not more than one spouse living.
 - f) Oath of allegiance to the Constitution of India.
6. No Travelling Allowances is admissible for the purpose of joining in the said post.
