Whereas the District Administration is satisfied that it is necessary to restrict the speed of certain motor vehicles in the interest of public safety or convenience or because of the nature of road.

Now therefore, in exercise of the powers conferred upon me by sub-section(2) of section 112 of the Motor Vehicle Act,1988 read with sub-rule (1) (a) of rule 173 of Odisha Motor Vehicles Rules,1993 & Section-115 of Motor Vehicle Act,1988, I Ashish Ishwar Patil, IAS, Collector & District Magistrate, Dhenkanal do here by fixed the maximum speed limit in respect of the class of motor vehicles in the areas and roads specified therein for interest of public safety & in Kapilash-Tangi PWD Road under Gondia Block from Deogan to Chhatighara and vice versa in Dhenkanal District to minimise the life threaten of wild life animal of Kapilash Wildlife Sanctuary

This Office earlier order No 2279 dt 01-08-2025 is here by stands modified.

The restriction is imposed within the revenue jurisdiction of the Dhenkanal District for a period of one-month w.e.f. dt.15.03.2026 to dt.14.04.2026 (for a period of one month).


