In exercising powers conferred upon me under Section. 115 of Motor vehicle Act, 1988, I, Ashish Ishwar Patil, IAS, District Magistrate, Dhenkanal having been authorized under sub-rule (1) of Rule 173 of Orissa Motor vehicle Rules, 1993 do hereby restrict plying of heavy Trucks / Trailers / vehicles in different places of Dhenkanal District as mentioned below in order to reduce traffic conjunction in the interest of the General Public & wild animals.

This restriction / prohibition shall remain in force for a period of further one month with effect from dt.01.04.2026 to dt.30.04.2026.
