

OFFICE ORDER

In pursuance of Letter No. 6634/IND-II-PH-1314 dated 30.04.2026 of the Addl. Chief Environmental Engineer, State Pollution Control Board, Odisha, Bhubaneswar, public hearing is proposed by M/s Tata Steel Ltd., Meramandali for expansion of Integrated Steel Plant from 5.6 MTPA Crude Steel to 7.1 MTPA Crude Steel and for 8.3 MTPA Finished Steel at Village- Narendrapur, P.O.- Kusupanga, District- Dhenkanal.
